  - President's Report
    - Updated 2023 MADWA Governing Documents final draft- In process
      - Per Barb, Dave, Gary, Bill, Peter, Karen (six homeowners) worked on updating Governing Documents (3 documents)
      - Inconsistency in the Attorney's proposed updates to the current MADWA HOA documents
      - Per the six homeowners, the documents are at a point where seeking Attorney's feedback
      - Attorney is now involved and looking to set time to discuss as a group.
      - Homeowners would like at least 2 homeowners present at the meeting with the attorney
      - The drafted documents are unfinished business currently; will need to be finalized, then have Special Meeting for homeowners vote
      - Evan Leech is also the attorney for Deacon's Walk
    - Renewal of lawn care/snow removal contract
      - Timberline contract renewed for October 2023 September 2026
    - October 26, 2022 MADWA Annual meeting minutes- Approved
  - Treasurer's Report
    - Treasure's Report of HOA Financial Statements as of September 30, 2023
      - MADWA Independent Accountant's Review Report for year-end
      - Updated Treasure's September Report available at annual meeting
      - Currently have \$50k in CD and looking to invest in additional CD
    - 2024 Annual Budget
      - Board approved 3% (\$12) increase for 2024 monthly due (\$408 per unit per month)- please update if have automatic payment set up for HOA due payments prior to Jan 2024
      - The increase in dues are due to Master Liability insurance coverage and increased cost for Timberline lawn and snow removal services
      - We are renewing with Timberline- awaiting for response from Timberline with the proposal of snow removal from garage to the end of first cement slab in front of garage doors and edging more frequently than 2 times per summer
      - Timberline is all inclusive with lawn, winter, and irrigation

- D. Election of the Board of Directors
  - 1 Board Member for 3-year Term Length
  - Secretary position open- no nomination or volunteer
  - Will need to replace open position or possibly need to hire Management Company to uphold HOA requirements
